## IV. ITEMS RECOMMENDED FOR BOARD ACTION

- 2023-24 Budget: No discussion was held
- Benefits for Paraprofessionals. An additional budget was presented with health insurance offered to 24 paras. This raised the mills from 2.75 to 5 mills. Director Wolsky spoke on the para sub rates and the benefits of being to offer new employees health insurance and a higher wage. This might encourage more staff to come work for us. Jordon Brown asked if salaries are shared to the districts, Director Wolsky noted they are percentage shared. Jordon Brown noted that he is not interested in increasing the amount when Oberon has no paras in the school. Jordon Brown also mentioned the ADM and tax valuation increase for Oberon. Mrs. Helseth stated that the budget is proposed that all 24 paras take the health insurance. This does not mean that all of them will take the insurance. Discussion was held on para wages included. Mrs. Helseth noted she is in favor of including health insurance benefits. Mrs. Helseth also noted she is in favor of a para wage increase. Janelle Helm made motion to approve a single health insurance to all paras, Mrs. Helseth seconded the motion. A role call vote was held.

Kent Dennis made a motion to approve the \$1 wage per hour increase to paras that are certified when they are clocked in and driving students. Matt Lokemoen seconded. All approved, motion carried.
